Approved: **Changing selection of Standing Committee officers**

The chair of the Standing Committee shall be the most senior member at large.~~ The officers of the Bouchercon Standing Committee shall include a chair, a treasurer, and a secretary, elected by the Standing Committee at the conclusion of the annual business meeting. The Standing Committee is encouraged to select a treasurer with a background in accounting or finance, and a secretary who is a lawyer.

~~F. The most junior member at large will serve as the recording secretary during their first year on the Standing Committee.”~~

Approved: **Changing disposition of net profits from local Bouchercon events**

Insert new “VIII. C. When local organizing committees prepare to close their books with funds in excess of their expenses, they shall transmit the balance to the Standing Committee, which shall use such funds for operations to support Bouchercon including when feasible providing a seed grant for each successful LOC bid.”

VII. a) The Anthony Awards shall be given for outstanding achievement in each category to honor the memory of Anthony Boucher. *insert new* i. The Anthony Awards shall be designated by the year they were ANNOUNCED, rather than the year the works were published/produced.
